PRIVACY STATEMENT

PacificCARE collects child care providers' personal data. Only business-related information such as name, address, phone number will be released for the following reasons:

- Posting your child care facility information on our website
- To assess your needs in order to provide you with a high quality of service and support through your relationship with PacificCARE
- In the case of License-Not-Required, information is collected in order to assess suitability for referrals when applicable

PacificCARE may share information with the following:

- Parents requesting referrals to child care facilities (PacificCARE clients only)
- The insurance broker, for the purpose of access to liability insurance coverage
- The Child Care Branch who funds this program and other selected organizations for the purpose of enabling them to share child care related information that we deem may be of interest to our clients, such as subsidy information or child care events, or for research purposes such as community mapping
- Personal data will be shared on a need-to-know basis with the Ministry or Child Care Licensing when there is a duty to report a concern for the health, safety and well-being of a child
- In the case of License-Not-Required, business contact information will be shared with the Ministry in order to be eligible for enhanced subsidy rates.

PacificCARE is committed to maintaining the principles of integrity, trust, and service with respect to the privacy of personal information. As part of our commitment, PacificCARE will protect the privacy of personal information collected from child care providers, parents and others during the course of its business operations and agrees to comply with the standards as laid out in the privacy laws.
